BACKGROUND

The California Department of Corrections and Rehabilitation (CDCR), California Prison Health Care Services (CPHCS), is requesting offers for a Oracle Fusion Middleware Developer to develop and support CPHCS' Fusion Middleware components within the Clinical Data Repository (CDR) system during the CDR Migration Project. Contractor will work in conjunction with CPHCS' Health Care Applications Development and Support Unit, and Allied Health Services, to provide development, implementation, maintenance, and knowledge transfer activities for the Clinical Applications Migration Project.

Contractor will report to CPHCS' Deputy Chief Information Officer (DCIO), Clinical Applications, or designee(s). In submitting an offer vendor must comply with the instructions found herein.

The term of the proposed Agreement is targeted for June 4 ~~20~~, 2011, through ~~November 14~~ December 19, 2012. CPHCS reserves the option to extend the Agreement for up to an additional eighteen (18) months at the same rate of award and/or to add additional funds up to the maximum CMAS threshold. The contract award is subject to availability of funds approved for this purpose and renewal of the IT Consulting Services CMAS.

All offers must be signed by an authorized officer of the company or firm who has legal and binding authority. By submitting an offer, your firm agrees to the terms and conditions stated in this Request for Offer and in accordance with your authorized Leveraged Procurement Agreement (i.e., California Multiple Award Schedule [CMAS] contract).
