QUESTIONS/STATEMENTS AND ANSWERS

1. Question(s)/Statement(s):

"I wanted to know what the max amount for this RFO is."

Answer(s)/Statement(s):

To ensure that rates offered are market driven CPHCS does not disclose budget allotments for Request for Offers.

- Please recognize that the maximum delegated spending authority amount for a California Multiple Awards Schedule (CMAS) agreement may be found on the California Department of General Services' (DGS), Procurement Division (PD), website located at www.dgs.ca.gov.

2. Question(s)/Statement(s):

Regarding sub-contracting:

"For all Agreements, with the exception of Interagency Agreements and other governmental entities/auxiliaries that are exempt from bidding, nothing contained in the Agreement, or otherwise, shall create any contractual relation between the State and any subcontractors, and no subcontract shall relieve Contractor of contractor's responsibilities and obligations hereunder. Contractor agrees to be as fully responsible to the State for the acts and omissions of its subcontractors and of persons either directly or indirectly employed by any of them as it is for the acts and omissions of persons directly employed by the Contractor. The Contractor's obligation to pay its subcontractors is an independent obligation from the State's obligation to make payments to the Contractor. As a result, the State shall have no obligation to pay or to enforce the payment of any moneys to any subcontractor.

For this RFO, subcontracting of proposed services is not permitted."

- The prime contractor must provide 100% of resources to the project (both Project Manager resources must be employees of the prime contracting firm?),

- or -

- Will CDCR allow for one of the Project Manager resources to be a subcontractor?"

Answer(s)/Statement(s):

Subcontracting of services from one Contractor to another (i.e., firm-to-firm as a pass through) shall not be permitted for performing requested services in RFO #10-034-ITS.

- However, the RFO requires identification of the person(s) who will perform work under the resulting contract. The person(s) identified may provide services either as the Contractor's employee(s) or as the Contractor's independent contractor(s).

3. Question(s)/Statement(s):

"In regards to Addendum 1, does this mean the solicitation is only for ONE project manager? The term "project managers" is pretty vague and could mean 1, 2, 4, etc. How many PM's is this solicitation for? Please advise. Thanks."

Answer(s)/Statement(s):

There is no limit on number of candidates an Offeror may submit.

4. Question(s)/Statement(s):

"The above mentioned RFO states that "The California Department of Corrections and Rehabilitation (CDCR), California Prison Health Care Services (CPHCS), is requesting offers for two (2) Project Managers (PMs) to manage designated Information Technology (IT) infrastructure projects(s) and related sub-projects."

1. Does this limit a vendor to two (2) resumes to be included in one RFO response?
2. If so, can a single vendor submit more than one response to the above mentioned RFO if they would like to propose more than two individuals for consideration?"

Answer(s)/Statement(s):

RFO #10-034-ITS, Addendum #1, struck the language limiting offers to two project managers.

- Please note that there is no limit on number of candidates an Offeror may submit.

5. Question(s)/Statement(s):

"If candidates are qualified for both requests, can we propose the same candidates – again giving CPHCS multiple options?"

Answer(s)/Statement(s):

Contractors may offer qualified candidates for an RFO they deem appropriate.

6. Question(s)/Statement(s):

"Please confirm that the addendum is stating that only 1(one) Project Manager is needed and that the \$3000 has been added for travel expense.

Answer(s)/Statement(s):

- RFO #10-034-ITS, Addendum #1, struck the language limiting offers to two project managers.
- RFO #10-034-ITS, Addendum #1, updated the travel budget to \$3,000.00, per award.

7. Question(s)/Statement(s):

"Also, if we have a subcontractor with a DVBE are the vendors still excluded from presenting a direct subcontractor meaning the person working is the company owner (not an employee of a company) leaving multiple layers?"

Answer(s)/Statement(s):

See answer/statement #2 above.

8. Question(s)/Statement(s):

"Item Number 9 of Response guidelines states: 'Offeror Declaration Form (GSPD-05-105); Not applicable. For this RFO, subcontracting of proposed services will not be permitted.'"

Since we have not seen this before in similar CDCR RFO's we are wondering if this was an error. "

Answer(s)/Statement(s):

No; this is not an error. See Answer/Statement #2 above.

9. Question(s)/Statement(s):

"Do we need to include a signed Non-disclosure and Confidentiality Statement in our response or can that be provided at a later date (prior to an interview for instance)?"

Answer(s)/Statement(s):

Offers submitted in response to RFO #10-034-ITS must be received prior to RFO due date and time, and include a signed non-disclosure agreement and confidentiality statement.

10. Question(s)/Statement(s):

"How many Project Manager roles are you attempting to fill with this RFO?"

Answer(s)/Statement(s):

In the event CPHCS determines that services would be best performed by awarding multiple agreements for this RFO, CPHCS reserves the right to make this determination and negotiate with Offerors have "best value" to award more than one company and/or firm.

- CPHCS has yet to determine the total number of Project Managers to be selected for award.

11. Question(s)/Statement(s):

"How many candidate resumes may we submit?"

Answer(s)/Statement(s):

Offerors are required to submit one (1) resume for each proposed candidate.

- Please note that the resume of Contractor's personnel must include: 1) all relevant work experience; 2) a start and end date for each job cited; and 3) three (3) customer references.

12. Question(s)/Statement(s):

"Two Project Managers has been lined out and now just reads "project managers"...I just wanted to check to see if it should be just 1 project manager, or if we can submit multiple names"

Answer(s)/Statement(s):

See Question #4.

13. Question(s)/Statement(s):

"Addendum #1 of RFO #10-034-ITS removed the specific requirement for two Project Managers and appears to leave open the total amount of services CPHCS wishes to procure. The remaining guidance appears in the Rate Sheet which still shows two line items for 2,016 hours (~1 year) of Project Manager time. Given that the term of the agreement is still one year, this indicates you are still looking for two Project Managers."

Answer(s)/Statement(s):

There is no limit on number of candidates an Offeror may submit. However, the total number of hours to be performed under the resulting contract may not exceed the number set forth in Exhibit B-1, Rate Sheet.

- Please note that Exhibit B-1 (Rate Sheet) for RFO #10-034-ITS is an example that would meet response guideline requirements.

14. Question(s)/Statement(s):

"On p. 6 of the RFO, the 'Best Value Criteria' requires technical experience that includes experience with 'large complex IT projects.' Can CPHCS provide clarification about what criteria is required to classify an IT project as large and complex?"

Answer(s)/Statement(s):

Size and complexity of a project includes a number of variables. For example, complexity and size may be defined by: cost (i.e., \$1 million or more); technical complexity; number of team members, stakeholder groups, sub-projects, number of interfaces (i.e., greater than 11), and/or term (i.e., greater than one year).

15. Question(s)/Statement(s):

"For the Certificate of Liability Insurance is it okay to have the Department of Corrections listed as the certificate holder instead of 'State of California'."

Answer(s)/Statement(s):

No; the Certificate of Insurance must indicate that the State of California is included as additional insured.

16. Question(s)/Statement(s):

"When I submit the electronic files do you prefer that everything be in one PDF file or can I submit multiple attachments?"

Answer(s)/Statement(s):

Offers may be submitted as a single PDF (Portable Document Format) document, or as multiple attachments.

- Please note that CPHCS' e-mail system generally limits attachments to 5 MB in size.

17. Question(s)/Statement(s):

"Attached herewith are addendum(s) issued by the department. From them it is not clear whether:

1. There still exists 2 positions of PM, or
2. If not, then is there any new cost sheet – Exhibit B1 still says to quote for 2 positions of PM?"

Answer(s)/Statement(s):

See Answer/Statement #13.

18. Question(s)/Statement(s):

"Addendum 1 of the RFO has retracted the number of PMs being requested. I would like to know if there is a limit to the number of PMs that can be submitted in response to this RFO?"

Answer(s)/Statement(s):

There is no limit on number of candidates an Offeror may submit.

19. Question(s)/Statement(s):

“Are the attachments expected to be completed in the submission available in an editable document form (e.g., Exhibit B-1 Rate Sheet)?”

Answer(s)/Statement(s):

Attachments to RFO 10-034-ITS are available in a PDF (Portable Document Format) document

20. Question(s)/Statement(s):

“Our firm would like to know if completion of the forms per requirement #17, Other Requirements, must occur as part of the proposal submission or whether these forms are to be completed only by the Consultant(s) selected to perform the services once an award has been made.

'17. Other Requirements:

a. Contractor Confidentiality Statement (Attachment B):

- The Political Reform Act of 1974 (Government Code Sections 81000-91015) requires consultants to file a Contractor Confidentiality Statement certifying no personal or financial interest with the Project and agreeing to keep all information concerning the project confidential.

b. Non-Disclosure Agreement (Attachment C)

c. Statement of Economic Interests (Form 700) - (Attachment D)”

Answer(s)/Statement(s):

Offers submitted in response to RFO #10-034-ITS must include all of the following: 1) Contractor Confidentiality Statement (Attachment B); 2) Non-Disclosure Agreement (Attachment C); and 3) Statement of Economic Interest (Form 700) – (Attachment D).

21. Question(s)/Statement(s):

Regarding number of resources:

“How many technical PMs do you expect to be proposed in each bidder response under this procurement? How many total technical PMs do you expect to hire under this procurement? Related questions include:

- a. The Addendum ‘Action’ on the first page lists two purposes for the addendum (education/degree and travel budget), however not indicated is the ‘striking out’ of the 2nd resource which is evident throughout. Is CPHCS seeking only one resource, or would CPHCS prefer to receive responses containing more than one staff resource?
- b. Although the 2nd resource is struck-out, it is not removed on the rate sheet. In fact the 2nd resource on the rate sheet is indicated also as full-time. Would CPHCS consider a bid involving 1 full-time resource plus one additional part-time

resource which we feel would add significant value to this important project? If so, would it be acceptable to present the part-time resource as optional (i.e., at CPHCS' discretion)?

- c. Further elaborate on the total makeup of the CPHCS team for the broader project, including sponsor, management, number/roles of other technical PM's, etc. "

Answer(s)/Statement(s):

There is no limit on number of candidates an Offeror may submit.

- Offers submitted in response to this RFO must include a detailed description of Contractor's approach for completing services in Exhibit A (Scope of Services) including, but not limited to, the functions, roles, and responsibilities of proposed personnel.
 - Offeror may choose to identify a resource that is available on a part-time basis but such resource may or may not meet CPHCS' project management needs.
- Please note that the Exhibit B-1 (Rate Sheet) included with RFO #10-034-ITS is an example of a Rate Sheet that meets response guideline requirements.

22. Question(s)/Statement(s):

Regarding Subcontracting:

"Please clarify the preclusion regarding subcontracting. Specifically, would CPHCS consider striking the preclusion to subcontracting in lieu of indicating, in the responses, where there is a subcontracting relationship? This may yield a higher volume of qualified staff candidates contained in the responses, from which CPHCS can choose from."

Answer(s)/Statement(s):

No. See Answer/Statement #2.

23. Question(s)/Statement(s):

Regarding Budget Contingency:

"Is award and purchase order authorization pending legislative approval of the 2010-11 state budget? In the event, after award, an active contract is cancelled owing to state budget/cash issues, will the vendor be paid timely for services delivered up to the cancellation point?"

Answer(s)/Statement(s):

Contract award is not pending legislative approval of California State Budget for Fiscal Year (FY) 2010/11. In the event that an in-force agreement is cancelled for lack of budget appropriation, vendor would be reimbursed for services rendered prior to notice of contract cancellation.

24. Question(s)/Statement(s):

Regarding Travel/Institutions:

"Please clarify the expected number of field visits, including listing the institutions/locations, purpose/duration of visits, expected meeting attendees, etc.? Also, there is language referring to interaction with inmates. This is assumed to be boiler language, and further that no direct or indirect interaction with inmates is anticipated in this contract. Is that correct?"

Answer(s)/Statement(s):

- The number of field visits required is unknown at this time. Locations/institutions, purpose/duration, expected meeting attendees, etc., will be dependent upon the specific project assigned;
- No direct or indirect interaction with inmates is anticipated as a result of consulting service activities.

25. Question(s)/Statement(s):

"For the Statement of Economic Interests, Form 700, I don't have any reportable interests. Is this form for me or for the consultants I'm proposing? Also, does Box #2, Jurisdiction of Office, apply to this or can I leave it blank?"

Answer(s)/Statement(s):

Both for the Offeror and proposed consultant(s). Yes, box # 2 applies.

26. Question(s)/Statement(s):

"Do we have to submit 2 candidates in responding to this RFO or could we submit just one candidate?"

Answer(s)/Statement(s):

Offerors may submit any number of candidates in response to RFO #10-034-ITS.

27. Questions(s)/Statements:

"Will CPHCS consider extending the due date, to account for delay in release of questions/answers?"

Answer(s)/Statement(s):

RFO #10-034-ITS, Addendum #3, extends the response due date to Wednesday, October 13, 2010. Corrections to the RFO have been made using the strike-out and underline font format method, as attached.

28. Question(s)/Statement(s):

"Please confirm our understanding of selection process:

In the selection process, if we don't submit, for example, a candidate with PMP certification, but meets all other requirements, we would not earn the 5 points associated with technical experience and therefore would earn less than 40 points in this category, or would this be deemed 'not responsive'?"

Answer(s)/Statement(s):

Proposed consultants must meet the mandatory qualifications to be considered for award (e.g., possession of a Project Management Professional [PMP] certification).

- If a response is missing required information (e.g., PMP certification) it may be deemed non-responsive.
- Responsive offers will be scored on “Best Value” criteria including, but not limited to, possession of a PMP certification (i.e., scored less than 5 points maximum).

The California Department of Corrections and Rehabilitation (CDCR), California Prison Health Care Services (CPHCS), is requesting offers for Project Managers (PMs) to manage designated Information Technology (IT) projects(s) and related sub-projects. Contractor(s) will report to CPHCS' Project Management Office (PMO) Director or designee. In submitting an offer vendor must comply with the instructions found herein.

The term of the proposed Agreement is targeted for November 1, 2010 through October 31, 2011. CPHCS reserves the option to extend the ensuing Agreement for two (2) additional years at the same rate of award and/or to add additional funds up to the maximum CMAS threshold. The contract award is subject to availability of funds approved for this purpose.

All offers must be signed by an authorized officer of the company or firm who has legal and binding authority. By submitting an offer, your firm agrees to the terms and conditions stated in this Request for Offer and in accordance with your authorized Leveraged Procurement Agreement (i.e., California Multiple Award Schedule [CMAS] contract).

RESPONSE GUIDELINES

This RFO, Offeror's response, the State's General Provisions – Information Technology (GSPD 401IT, effective 06/08/2010), and applicable IT Personal Services Special Provisions will be made part of the Standard Agreement and contract file.

Offers must be submitted electronically to the departmental contact address noted on page 1. All pages of Offeror's response received prior to due date and time will be considered. CPHCS is not responsible for any e-mail loss and/or failure to receive an Offeror's response. CPHCS assumes no responsibility if Offeror cannot transmit their response electronically to the departmental e-mail address and/or if entire response is not received prior to Request for Offer (RFO) due date.

The delivery of any offer via U.S. mail, private delivery service, and/or by personal service will not be accepted by CPHCS. In the event of such delivery, CPHCS may consider the offer as non-responsive.

Offers submitted in response to this RFO must include all of the following information:

1. Cover letter signed by the authorized officer of the company or firm who has legal and binding authority;
2. Full legal name of Offeror's organization or firm, mailing address, telephone and facsimile numbers;
3. Name, telephone number, and electronic mail (i.e., e-mail) address of Offeror's contact person;
4. Submission date of Offer;
5. A copy of Offeror's CMAS contract that includes the California Department of General Services (DGS) logo, CMAS number, term and DGS' signature approval;
6. Copy of Liability Insurance Certificate;

Offeror must provide CPHCS with a Certificate of Insurance showing that there is liability insurance currently in effect for Offeror of not less than \$1,000,000, per occurrence, for bodily injury and property damage liability combined. The Certificate of Insurance must include the following provisions:

- a. The insurer will not cancel the insured's coverage without 30 days prior written notice to the State;¹ and
- b. The State of California is included as additional insured.

7. Proof of Worker's Compensation Insurance;

Offeror shall provide CPHCS with a Certificate of Insurance showing that there is current workers' compensation insurance coverage for its employees who will be engaged in performance of the requested services. The Certificate of Insurance must include the provision that insurer will not cancel the insured's coverage without 30 days prior written notice to the State.

Any modifications to SOW of the ensuing Agreement will be defined, documented and mutually agreed upon by Contractor and , or designee, and may be reimbursed on a time and materials rate basis as proposed on Exhibit B-1 (Rate Sheet).

EXHIBIT A STATEMENT OF WORK

A. BACKGROUND AND PURPOSE

The California Prison Health Care Receivership Corporation is a non-profit organization created to house activities of the Federal Receiver. United States District Court Judge, Thelton E. Henderson, established the Receivership as the result of a 2001 class action lawsuit (Plata v. Schwarzenegger) brought against the State of California over the quality of medical care in the State's prison system.

All activities of the Receivership have one common purpose: to create a collaborative environment where custody and health care staff improve upon the quality of medical services in California prisons in order to meet constitutional standards while reducing avoidable morbidity and mortality. The Receiver has adopted six goals that are necessary for CDCR's health care program to rise to constitutionally acceptable and sustainable levels. The goals are: 1) ensure timely access to health care services; 2) establish a prison medical program addressing the full continuum of health care services; 3) recruit, train and retain a professional quality medical workforce; 4) implement a quality assurance and continuous improvement program; 5) establish medical support infrastructure; and 6) provide for necessary clinical, administrative and housing facilities.

The above goals encompass key aspects of CDCR's health care delivery system and the Receiver is undertaking a broad organizational change to improve its mental, dental and health care programs. One organizational strategy to improve CDCR's overall health care program is to establish information technologies (IT) for clinical support. The CPHCS has embarked on a number of IT projects necessary to achieve the Receiver's efforts in raising the level of health care of patient-inmates to constitutional standards. Some of these projects include, but are not limited to: 1) Clinical Data Repository (CDR); 2) Dictation and Transcription; 3) Mental Health Tracking System (MHTS); 4) Network; 5) CPHCS GuardianRx Pharmacy Conversion 6) Access to Care - Utilization Management 7) Laboratory Service Management 8) Health Care Scheduling System 9) Clinical Imaging Services and 10) Health Care Data Center.

To support the continued execution of these projects toward implementation, CPHCS seeks experienced Project Managers (PMs) who will have responsibility for managing designated IT infrastructure project(s) and related sub-projects. CPHCS has yet to determine how many vendors will be selected for award nor what projects a consultant will be assigned to. CPHCS does anticipate executing Agreement(s) with an execution date of November 1, 2010, but some consultants will begin performance after November 1, 2010. A consultant's performance start date is dependent on multiple factors including, but not limited to: project phase, project priority, project budget, etc.

In summary, CPHCS seeks PMs for a variety of IT projects whereby all selected vendors will have a contract execution date of November 1, 2010, but consultant performance may begin at a later date. Contractor reimbursement will be subject to consultant's performance start date versus the agreement's date of execution. Should a consultant be unavailable to begin performance CPHCS will allow contractor to propose a substitute in accordance with Exhibit A (Statement of Work), Item D.5 (Assumptions and Constraints), involving personnel substitutions.

The PMs will report to CPHCS' Project Management Office (PMO) Director or designee(s).

B. CONSULTANT QUALIFICATIONS

Consultants must meet the Mandatory Qualifications to be considered for award. Consultants will be evaluated on expertise and experience stated in the resume against the mandatory qualifications. At discretion of CPHCS, interviews may be a part of the selection process.

Mandatory Qualifications:

1. At least five (5) years of increasingly responsible project management experience applying the principles, methods, techniques, and tools for developing, scheduling, coordinating, and managing projects and resources, including integration, scope, time, cost, quality, human resources, communications, risk and procurement management;
2. At least three (3) years experience in a management capacity as a full-time project of one or more large IT projects;
3. At least two (2) years experience managing IT projects with multiple geographical business locations;
4. Possession of a Project Management Professional (PMP) certification;
5. Knowledge of state IT policy and governance processes; and
6. Demonstrated leadership abilities and experience working with state staff and management, and public sector executives.

Desirable Qualifications:

1. Experience in health care project management;
2. Experience with process improvement methodologies such as Six-Sigma or Lean, etc;
3. Knowledge of various types of contracts, techniques for purchases of goods and/or services, and financial management;
4. Experience with business reengineering projects,
5. Understanding of State budget process;
6. Experience with projects supporting correctional environments and processes; and
7. Ability to work in a team environment as well as independently.

C. SCOPE OF SERVICES

Contractor's consultant(s) shall perform all of the following:

1. Develop and maintain the Project Management Plan and all other project management artifacts required by the CPHCS Project Management Office;
2. Act as a single point of contact for the project with CPHCS' Chief Information Officer, PMO Director, and/or Project Sponsors;
3. Provide management of project including, but not limited to, coordination of project activities with other project teams;
4. Manage project according to current work plans and coordinate availability of authorized resources for project;
5. Manage all project resources and ensure that appropriate funds are available throughout life of project;

6. Provide direction for State and contractor resources assigned to project;
7. Provide input and assistance to other project team members for maintenance of overall project schedule(s) and plan(s);
8. Establish and maintain regular project communications with CIO, PMO Director, and/or key stakeholders;
9. Collaborate with staff members to identify issues and risks, maintain issue log(s), ensure prompt attention to and resolution of issues, and escalate, when necessary;
10. Assist with preparation of issue, decision, and research documents;
11. Maintain status report(s), budget/cost report(s), and issue and risk report(s);
12. Assist project managers with logistics, plans, documentation, and review products, upon PMO Director, or designee, request;
13. Manage change management and change control in coordination with CDCR and CPHCS programs, and IT staff;
14. Monitor and maintain development and implementation schedules;
15. Develop and implement quality assurance processes to ensure all project objectives are met, tasks/milestones are achieved, and stakeholder expectations are managed;
16. Complete services in agreed upon timeframe(s), including a monthly status report to PMO Director describing current project status, services produced during previous month, plans for upcoming month, and any issues and/or risks identified during reporting period; and
17. Participate in coordination meetings, provide project management expertise, gather required information, and make recommendations, as appropriate.
 - The consultant(s) will actively participate in information gathering meetings, fact-finding meetings, working sessions, status reporting (both verbal and written), presentations, and general communication(s) on an ongoing basis to help ensure success of the project.

D. ASSUMPTIONS AND CONSTRAINTS

1. Consultant's work hours must be consistent with CPHCS on-site staff. CPHCS' normal business hours are 8:00 a.m. to 5:00 p.m., Monday through Friday, excluding State holidays and mandated furloughs.
 - No overtime pay will be authorized for non-standard work hours.
2. The work location will be at 660 J Street, Sacramento, California, or at another designated location within the greater Sacramento area. Travel to the institutions is expected and may be required from consultants.
3. Any modifications to SOW of the ensuing Agreement will be defined, documented and mutually agreed upon by Contractor and PMO Director or designee.
4. Services not specified in Scope may only be performed pursuant to a work authorization signed by CPHCS.
5. Contractor must submit, in advance, a resume of all personnel substitutions. All Contractor personnel substitutions must be approved by the CPHCS PMO Director, or designee, prior to substituted personnel commencing work.

6. CPHCS, in its sole discretion, reserves the right to require Contractor to substitute personnel.
7. The CPHCS reserves the right to renegotiate services deemed necessary to meet the needs of the project according to State priorities. CPHCS and the Contractor shall mutually agree to all changes; and renegotiated services outside the scope of the original contract may require control agency approval prior to commencement of work.
 - Work Authorization

Either party may at any time propose a change to Scope. If Contractor believes that such change will increase Contractor's costs or delay completion, the parties will negotiate in good faith to try to accommodate such request(s). Contractor will price any additional fees, at CPHCS' option, based on time and material rate(s) or fixed cost. Contractor will disclose and explain to CPHCS its method of pricing a change order (i.e., work authorization). At CPHCS' request, the parties will use project estimation tools to aid in determining pricing and to ensure that it is competitive in the marketplace. No change will be effective unless and until set forth in a written amendment to the Agreement, which is approved and assigned by both parties. Any agreed upon modifications will be performed by Contractor in accordance with the amendment and Agreement provisions. Any failure to agree to a proposed change will not impair the enforceability of other Agreement terms or Scope.
8. Contractor represents that it has, or shall secure at its own expense, all staff to perform services described in the ensuing Agreement.
9. CPHCS and Contractor are mutually obligated to keep open channels of communications to ensure successful performance of the ensuing Agreement. Both parties are responsible for communicating any potential problem(s) or issue(s) to CPHCS' PMO Director and the Contractor, respectively, within eight (8) hours of becoming aware of said problem(s).
10. Contractor certifies that it has appropriate systems and controls in place to ensure that State funds will not be used in performance of this Agreement for the acquisition, operation, or maintenance of computer software in violation of copyright laws.

E. CPHCS ROLES AND RESPONSIBILITIES

1. CPHCS will provide cubicle accommodations at 660 J Street, Sacramento, California or another designated location in the greater Sacramento area. Accommodations may include a desk, telephone, computer hardware, and software necessary for performance of the work.
2. CPHCS will be responsible for monitoring and reviewing of services as invoiced.
3. CPHCS will help resolve and escalate issues within the organization, as necessary.
4. CPHCS may provide Contractor access to applicable files, reports, contracts, documents, and other relevant information.
5. CPHCS will provide staff availability for consultation meetings.
6. Provision of clerical or other support services is strictly at the option of CPHCS. Contractor should assume that CPHCS will not provide any assistance of a clerical nature for documents or telephone support.

F. CONTRACTOR ROLES AND RESPONSIBILITIES

In addition to Scope of Services specified in Item C above, Contractor is required to do all of the following:

1. Comply with all applicable State and Agency policies and procedures, including those enumerated in Exhibit C (Special Provisions).
 - By accepting this Agreement, Contractor (including personnel) acknowledges that he/she has read and agrees to the provisions of Exhibit C;
2. Return all State property including security badges, computer laptop, work products, etc., prior to termination of the Agreement;
3. Be tested for Tuberculosis and certified to be free of tuberculosis on the TB Infectious Free Staff Certification in order to gain entrance to the Institutions;
4. Complete a Request for Gate Clearance Form, Application for Identification Card, and/or Emergency Notification form in order to gain entrance to the institutions;
5. Agree to abide by the Digest of Laws Related to Association with Prison Inmates;
6. Submit weekly timesheets to track actual time worked through the Clarity Portfolio Management System (Clarity). The PMO Director or designee will endorse these timesheets at the end of every workweek; and
7. Perform any other duties as requested by CPHCS' CIO or designee.

G. PERIOD OF PERFORMANCE

The term of the proposed Agreement is targeted for November 01, 2010 through October 31, 2011. The CPHCS reserves the right to extend the contract for two (2) additional years at the same rate of award, and/or to add additional funds up to the maximum CMAS threshold.

At any time during the term of the ensuing Agreement CPHCS, in its sole discretion, may instruct Contractor to limit the amount of time being performed by the assigned consultant.

H. EVALUATION OF CONTRACTOR

CPHCS' PMO Director, or designee, will complete a written evaluation of Contractor's performance under the ensuing Agreement within sixty (60) days following the term end date. The evaluation shall be prepared on the Contract/Contractor Evaluation form (STD 4) and maintained in the Agreement file for three (3) years. If Contractor's performance is deemed unsatisfactory, a copy of the evaluation shall be sent to the California Department of General Services (DGS), Office of Legal Services (OLS), within five (5) days, and to Contractor within fifteen (15) days, following completion of the evaluation.

I. TERMINATION

Notwithstanding provisions #21, #22, and #23 of the State's General Provisions – IT (GSPD 401-IT, effective June 8, 2010), CPHCS reserves the right to terminate the ensuing Agreement immediately with or without cause.

EXHIBIT B
BUDGET DETAIL AND PAYMENT PROVISIONS

1. INVOICING AND PAYMENT

For services satisfactorily rendered, and upon receipt and approval of invoices, CPHCS agrees to reimburse Contractor for said services, no more than monthly in arrears and in accordance with Exhibit B-1 (Rate Sheet). Unless otherwise specified, Contractor services shall be shall be invoiced and reimbursed on a time-and-materials basis.

Contractor shall submit an invoice in triplicate (with original signature in blue-ink) specifying work completed by consultant, number of hours performed, and any outstanding issues and/or concerns that need to be addressed.

All invoices shall be submitted with supporting documentation that properly details all charges, expenses, and direct costs (e.g., Clarity time sheets, etc.). All invoices submitted by Contractor to CPHCS must identify the Purchase Order and Agreement numbers. Any invoices submitted without the above referenced information may be returned to Contractor for re-processing.

2. BUDGET CONTINGENCY CLAUSE

- a. It is mutually agreed that if the California State Budget Act for the current fiscal year and/or any subsequent fiscal years covered under this Agreement does not appropriate sufficient funds for the project, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to Contractor, or to furnish any other considerations under this Agreement and Contractor shall not be obligated to perform any provisions of the Agreement.
- b. If funding for purposes of this project is reduced or deleted for any fiscal year by the California State Budget Act, the State shall have the option to either cancel the Agreement with no liability occurring to the State, or offer an Agreement amendment to Contractor to reflect the reduced amount.

3. PROMPT PAYMENT CLAUSE

Payment will be made in accordance with, and within the time specified in, Government Code Chapter 4.5, commencing with Section 927. Payment to small/micro businesses shall be made in accordance with and within the time specified in Chapter 4.5, Government Code 927 et seq.

4. SUBCONTRACTOR

For all Agreements, with the exception of Interagency Agreements and other governmental entities/auxiliaries that are exempt from bidding, nothing contained in the Agreement, or otherwise, shall create any contractual relation between the State and any subcontractors,

and no subcontract shall relieve Contractor of contractor's responsibilities and obligations hereunder. Contractor agrees to be as fully responsible to the State for the acts and omissions of its subcontractors and of persons either directly or indirectly employed by any of them as it is for the acts and omissions of persons directly employed by the Contractor. The Contractor's obligation to pay its subcontractors is an independent obligation from the State's obligation to make payments to the Contractor. As a result, the State shall have no obligation to pay or to enforce the payment of any moneys to any subcontractor.

For this RFO, subcontracting of proposed services is not permitted.

5. TRAVEL AND MISCELLANEOUS EXPENSES

Travel outside the greater Sacramento metropolitan area will be necessary as CPHCS has correctional institutions and regional offices located throughout the State

Any reimbursable travel and/or other expenses must be approved in advance by CPHCS' PMO Director or designee and itemized in Contractor's invoice. Travel reimbursement may not exceed the rates, terms, and conditions that apply to comparable State employees, in accordance with travel rules and regulations, as specified in California Code of Regulations (CCR), Title 2, Division 1, Chapter 3, and/or the California Department of Personnel Administration (DPA), Sections 599.619 through 599.631. Travel expenses shall be submitted on a State of California Travel Expense Claim, Std. 262, and are to be submitted with Contractor's monthly invoice for the applicable time period.

No travel or parking within the Sacramento metropolitan area will be paid. Only approved business travel originating at the CPHCS site may be reimbursed. Travel to and from the consultant's home or business to the primary CPHCS project site is not reimbursable, unless otherwise expressly authorized by CPHCS.

For purposes of this RFO, the travel budget is \$3,000.00.

EXHIBIT C
CDCR SPECIAL PROVISIONS

1. ACCOUNTING PRINCIPLES

The Contractor will adhere to generally accepted accounting principles as outlined by the American Institute of Certified Public Accountants. Dual compensation is not allowed; a Contractor cannot receive simultaneous compensation from two or more funding sources for the same services performed even though both funding sources could benefit.

2. SUBCONTRACTOR/CONSULTANT INFORMATION

Contractor is required to identify all subcontractors who will perform labor or render services in the performance of the Agreement. Additionally, the Contractor shall notify the CPHCS Contract Manager, within ten (10) working days, of any changes to the subcontractor and/or consultant information.

3. EMPLOYMENT OF EX-OFFENDERS

a. Contractor cannot and will not either directly, or via a subcontracted consultant and/or firm, employ in connection with this Agreement:

- (1) Ex-Offenders on active parole or probation;
- (2) Ex-Offenders at any time if they are required to register as a sex offender pursuant to Penal Code Section 290 or if such ex-offender has an offense history involving a “violent felony” as defined in subparagraph (c) of Penal Code Section 667.5; or
- (3) Any ex-felon in a position which provides direct supervision of parolees.

b. Ex-Offenders who can provide written evidence of having satisfactorily completed parole or probation may be considered for employment by the Contractor subject to the following limitations:

- (1) Contractor shall obtain the prior written approval to employ any such ex-offender from the Authorized Administrator; and
- (2) Any ex-offender whose assigned duties are to involve administrative or policy decision-making; accounting, procurement, cashiering, auditing, or any other business-related administrative function shall be fully bonded to cover any potential loss to the State of California.

4. LICENSES AND PERMITS

The Contractor shall be an individual or firm licensed to do business in California and shall obtain at Contractor’s expense all license(s) and permit(s) required by law for accomplishing any work required in connection with this Agreement.

In the event any license(s) and/or permit(s) expire at any time during the term of this Agreement, Contractor agrees to provide the CPHCS with a copy of the renewed license(s) and/or permit(s) within thirty (30) days following the expiration date. In the event the

Contractor fails to keep in effect at all times all required license(s) and permit(s), the State may, in addition to any other remedies it may have, terminate this Agreement upon occurrence of such event.

5. CONFLICT OF INTEREST

The Contractor and their employees shall abide by the provisions of Government Code (GC) Sections 1090, 81000 et seq., 82000 et seq., 87100 et seq., and 87300 et seq., Public Contract Code (PCC) Sections 10335 et seq. and 10410 et seq., California Code of Regulations (CCR), Title 2, Section 18700 et seq. and Title 15, Section 3409, and the Department Operations Manual (DOM) Section 31100 et seq. regarding conflicts of interest.

a. Contractors and Their Employees

•

Consultant Contractors shall file a Statement of Economic Interests, Fair Political Practices Commission (FPPC) Form 700 prior to commencing services under the Agreement, annually during the life of the Agreement, and within thirty (30) days after the expiration of the Agreement. Other service Contractors and/or certain of their employees may be required to file a Form 700 if so requested by the CDCR or whenever it appears that a conflict of interest may be at issue. Generally, service Contractors (other than consultant Contractors required to file as above) and their employees shall be required to file an FPPC Form 700 if one of the following exists:

- (1) The Agreement service has been identified by the CDCR as one where there is a greater likelihood that a conflict of interest may occur;
- (2) The Contractor and/or Contractor's employee(s), pursuant to the Agreement, makes or influences a governmental decision; or
- (3) The Contractor and/or Contractor's employee(s) serves in a staff capacity with the CDCR and in that capacity participates in making a governmental decision or performs the same or substantially all the same duties for the CDCR that would otherwise be performed by an individual holding a position specified in the CDCR's Conflict of Interest Code.

b. Current State Employees

- (1) No officer or employee shall engage in any employment, activity or enterprise from which the officer or employee receives compensation or has a financial interest and which is sponsored or funded by any state agency, unless the employment, activity or enterprise is required as a condition of regular state employment.
- (2) No officer or employee shall contract on his or her own behalf as an independent Contractor with any state agency to provide goods or services.
- (3) In addition to the above, CDCR officials and employees shall also avoid actions resulting in or creating an appearance of:
 - (a) Using an official position for private gain;
 - (b) Giving preferential treatment to any particular person;

- (c) Losing independence or impartiality;
 - (d) Making a decision outside of official channels; and
 - (e) Affecting adversely the confidence of the public or local officials in the integrity of the program.
- (4) Officers and employees of the Department must not solicit, accept or receive, directly or indirectly, any fee, commission, gratuity or gift from any person or business organization doing or seeking to do business with the State.

c. Former State Employees

- (1) For the two year (2-year) period from the date he or she left state employment, no former state officer or employee may enter into an Agreement in which he or she engaged in any of the negotiations, transactions, planning, arrangements or any part of the decision-making process relevant to the Agreement while employed in any capacity by any state agency.
- (2) For the twelve-month (12-month) period from the date he or she left state employment, no former state officer or employee may enter into an Agreement with any state agency if he or she was employed by that state agency in a policy-making position in the same general subject area as the proposed Agreement within the 12-month period prior to his or her leaving state service.

In addition to the above, the Contractor shall avoid any conflict of interest whatsoever with respect to any financial dealings, employment services, or opportunities offered to inmates or parolees. The Contractor shall not itself employ or offer to employ inmates or parolees either directly or indirectly through an affiliated company, person or business unless specifically authorized in writing by the CDCR. In addition, the Contractor shall not (either directly, or indirectly through an affiliated company, person or business) engage in financial dealings with inmates or parolees, except to the extent that such financial dealings create no actual or potential conflict of interest, are available on the same terms to the general public, and have been approved in advance in writing by the CDCR. For the purposes of this paragraph, “affiliated company, person or business” means any company, business, corporation, nonprofit corporation, partnership, limited partnership, sole proprietorship, or other person or business entity of any kind which has any ownership or control interest whatsoever in the Contractor, or which is wholly or partially owned (more than 5% ownership) or controlled (any percentage) by the Contractor or by the Contractor’s owners, officers, principals, directors and/or shareholders, either directly or indirectly. “Affiliated companies, persons or businesses” include, but are not limited to, subsidiary, parent, or sister companies or corporations, and any company, corporation, nonprofit corporation, partnership, limited partnership, sole proprietorship, or other person or business entity of any kind that is wholly or partially owned or controlled, either directly or indirectly, by the Contractor or by the Contractor’s owners, officers, principals, directors and/or shareholders.

The Contractor shall have a continuing duty to disclose to the State, in writing, all interests and activities that create an actual or potential conflict of interest in performance of the Agreement.

The Contractor shall have a continuing duty to keep the State timely and fully apprised in writing of any material changes in the Contractor's business structure and/or status. This includes any changes in business form, such as a change from sole proprietorship or partnership into a corporation or vice-versa; any changes in company ownership; any dissolution of the business; any change of the name of the business; any filing in bankruptcy; any revocation of corporate status by the Secretary of State; and any other material changes in the Contractor's business status or structure that could affect the performance of the Contractor's duties under the Agreement.

If the Contractor violates any provision of the above paragraphs, such action by the Contractor shall render this Agreement void.

Members of boards and commissions are exempt from this section if they do not receive payment other than payment for each meeting of the board or commission, payment for preparatory time and payment for per diem.

6. DISCLOSURE

Neither the State nor any State employee will be liable to the Contractor or its staff for injuries inflicted by inmates or parolees of the State. The State agrees to disclose to the Contractor any statement(s) known to State staff made by any inmate or parolee which indicates violence may result in any specific situation, and the same responsibility will be shared by the Contractor in disclosing such statement(s) to the State.

7. SECURITY CLEARANCE/FINGERPRINTING

The State reserves the right to conduct fingerprinting and/or security clearance through the California Department of Justice, Bureau of Criminal Identification and Information (BCII), prior to award and at any time during the term of the Agreement, in order to permit Contractor and/or Contractor's employees' access to State premises. The State further reserves the right to terminate the Agreement should a threat to security be determined.

8. NOTIFICATION OF PERSONNEL CHANGES

Contractor must notify the State, in writing, of any changes of those personnel allowed access to State premises for the purpose of providing services under this Agreement. In addition, Contractor must recover and return any State-issued identification card provided to Contractor's employee(s) upon their departure or termination.

9. NON ELIGIBLE ALIEN CERTIFICATION

By signing this Agreement Contractor certifies, under penalty of perjury, that Contractor, if a sole proprietor, is not a nonqualified alien as that term is defined by the United States Code (U.S.C.) Title 8, Chapter 14, Section 1621 et seq.

The following provisions apply to services provided on departmental and/or institution grounds:

10. BLOODBORNE PATHOGENS

Provider shall adhere to California Division of Occupational Safety and Health (CAL-OSHA) regulations and guidelines pertaining to bloodborne pathogens.

11. TUBERCULOSIS (TB) TESTING

In the event that the services required under this Agreement will be performed within a CDCR institution/parole office/community based program, prior to the performance of contracted duties, Contractors and their employees who are assigned to work with inmates/parolees on a regular basis shall be required to be examined or tested or medically evaluated for TB in an infectious or contagious stage, and at least once a year thereafter or more often as directed by CDCR. Regular contact is defined as having contact with inmates/parolees in confined quarters more than once a week.

Contractors and their employees shall be required to furnish to CDCR, at no cost to CDCR, a form CDCR 7336, "Employee Tuberculin Skin Test (TST) and Evaluation," prior to assuming their contracted duties and annually thereafter, showing that the Contractor and their employees have been examined and found free of TB in an infectious stage. The form CDCR 7336 will be provided by CDCR upon Contractor's request.

12. PRIMARY LAWS, RULES, AND REGULATIONS REGARDING CONDUCT AND ASSOCIATION WITH STATE PRISON INMATES

Individuals who are not employees of the California Department of Corrections and Rehabilitation (CDCR), but who are working in and around inmates who are incarcerated within California's institutions/facilities or camps, are to be apprised of the laws, rules and regulations governing conduct in associating with prison inmates. The following is a summation of pertinent information when non-departmental employees come in contact with prison inmates.

By signing this contract, the Contractor agrees that if the provisions of the contract require the Contractor to enter an institution/facility or camp, the Contractor and any employee(s) and/or subcontractor(s) shall be made aware of and shall abide by the following laws, rules and regulations governing conduct in associating with prison inmates:

- a. Persons who are not employed by CDCR, but are engaged in work at any institution/facility or camp must observe and abide by all laws, rules and regulations governing the conduct of their behavior in associating with prison inmates. Failure to comply with these guidelines may lead to expulsion from CDCR institutions/facilities or camps.

- b. CDCR does not recognize hostages for bargaining purposes. CDCR has a "NO HOSTAGE" policy and all prison inmates, visitors, and employees shall be made aware of this.

- c. All persons entering onto institution/facility or camp grounds consent to search of their person, property or vehicle at any time. Refusal by individuals to submit to a search of their person, property, or vehicle may be cause for denial of access to the premises.

- d. Persons normally permitted to enter an institution/facility or camp may be barred, for cause, by the CDCR Director, Warden, and/or Regional Parole Administrator.

- e. It is illegal for an individual who has been previously convicted of a felony offense to enter into CDCR institutions/facilities or camps without the prior approval of the Warden. It is also illegal for an individual to enter onto these premises for unauthorized purposes or to refuse to leave said premises when requested to do so. Failure to comply with this provision could lead to prosecution.

- f. Encouraging and/or assisting prison inmates to escape are a crime. It is illegal to bring firearms, deadly weapons, explosives, tear gas, drugs or drug paraphernalia on CDCR institutions/facilities or camp premises. It is illegal to give prison inmates firearms, explosives, alcoholic beverages, narcotics, or any drug or drug paraphernalia, including cocaine or marijuana.

- g. It is illegal to give or take letters from inmates without the authorization of the Warden. It is also illegal to give or receive any type of gift and/or gratuities from prison inmates.

- h. In an emergency situation the visiting program and other program activities may be suspended.

- i. For security reasons, visitors must not wear clothing that in any way resembles state issued prison inmate clothing (blue denim shirts, blue denim pants).

- j. Interviews with SPECIFIC INMATES are not permitted. Conspiring with an inmate to circumvent policy and/or regulations constitutes a rule violation that may result in appropriate legal action.

13. CLOTHING RESTRICTIONS

While on institution grounds, Contractor and all its agents, employees, and/or representatives shall be professionally and appropriately dressed in clothing distinct from that worn by inmates at the institution. Specifically, blue denim pants and blue chambray shirts, orange/red/yellow/white/chartreuse jumpsuits and/or yellow rainwear shall not be worn onto institution grounds, as this is inmate attire. The Contractor should contact the institution regarding clothing restrictions prior to requiring access to the institution to assure the Contractor and their employees are in compliance.

14. TOBACCO-FREE ENVIRONMENT

Pursuant to Penal Code Section 5030.1, the use of tobacco products by any person on the grounds of any institution or facility under the jurisdiction of the Department of Corrections and Rehabilitation is prohibited.

15. SECURITY REGULATIONS

- a. Unless otherwise directed by the entrance gate officer and/or Contract Manager, the Contractor, Contractor's employees and subcontractors shall enter the institution through the main entrance gate and park private and nonessential vehicles in the designated visitor's parking lot. Contractor, Contractor's employees and subcontractors shall remove the keys from the ignition when outside the vehicle and all unattended vehicles shall be locked and secured while on institution grounds.
- b. Any State- and Contractor-owned equipment used by the Contractor for the provision of contract services, shall be rendered temporarily inoperative by the Contractor when not in use, by locking or other means unless specified otherwise.
- c. In order to maintain institution safety and security, periodic fire prevention inspections and site searches may become necessary and Contractor must furnish keys to institutional authorities to access all locked areas on the worksite. The State shall in no way be responsible for Contractor's loss due to fire.
- d. Due to security procedures, the Contractor, Contractor's employees and subcontractors may be delayed at the institution vehicle/pedestrian gates and sally ports. Any loss of time checking in and out of the institution gates and sally ports shall be borne by the Contractor.
- e. Contractor, Contractor's employees and subcontractors shall observe all security rules and regulations and comply with all instructions given by institutional authorities.
- f. Electronic and communicative devices such as pagers, cell phones and cameras/microcameras are not permitted on institution grounds.
- g. Contractor, Contractor's employees and subcontractors shall not cause undue interference with the operations of the institution.
- h. No picketing is allowed on State property.

16. GATE CLEARANCE

Contractor and Contractor's employee(s) and/or subcontractors(s) must be cleared prior to providing services. The Contractor will be required to complete a Request for Gate Clearance for all persons entering the facility a minimum of ten (10) working days prior to commencement of service. The Request for Gate Clearance must include the person's name, social security number, valid state driver's license number or state identification card number and date of birth. Information shall be submitted to the Contract Liaison or his/her designee. CDCR uses the Request for Gate Clearance to run a California Law Enforcement Telecommunications System (CLETS) check. The check will include a California Department of Motor Vehicles check, Wants and Warrants check, and Criminal History check.

Gate clearance may be denied for the following reasons: Individual's presence in the institution presents a serious threat to security, individual has been charged with a serious crime committed on institution property, inadequate information is available to establish positive identity of prospective individual, and/or individual has deliberately falsified his/her identity.

All persons entering the facilities must have a valid state driver's license or photo identification card on their person.

17. BUSINESS ASSOCIATE AGREEMENT

The awarded Contractor will be required meet provisions of the Health Insurance Portability and Accountability Act of 1996, Pub. L. No. 104-191 ("HIPAA") and the regulations promulgated thereunder. The Business Associate Agreement can be located at the link below:

18. ELECTRONIC WASTE RECYCLING

The Provider certifies that it complies with the requirements of the Electronic Waste Recycling Act of 2003, Chapter 8.5, Part 3 of division 30, commencing with Section 42460 of the Public Resources Code, relating to hazardous and solid waste. Provider shall maintain documentation and provide reasonable access to its records and documents that evidence compliance.
